## Purpose of data processing

The purpose of this data processing is to process your application for TU Wien mobility programs and their implementation.

Your application will be processed via Mobility Online, as this program is an external application, parts of the above data will be retrieved directly from TISS or Single Sign On and inserted into your application. Retrieved data in detail:

- Name
- Date of birth
- Matriculation number
- Email address (TUW address)
- Active studies

Furthermore, data that is relevant for the study program is transferred back to TISS, especially data that is relevant for admission and re-registration at TU Wien.

#### Legal basis for data processing

The legal basis for this data processing is the performance of a task carried out in the public interest in accordance with Article 6 par 1 e GDPR (in conjunction with § 60, § 63 UG, Annex 7 to § 10 para. 4 and Annex 8 to § 12 par 2 Education Documentation Act).

#### **Transmission**

Depending on the mobility program selected, it may be necessary to transfer personal data to a third country (non-EU or EEA country). Depending on the circumstances, the legal basis for such transfers is § 2j FOG in conjunction with § 38a par 4 of FOG, Article 49 par 1 b or c GDPR.

# The duration of data storage

We store the data received from you, if necessary only a part of it, as long as it is necessary for the processing of your mobility program and beyond that, as long as legal retention periods exist or as long as legal claims can be asserted against the Vienna University of Technology, or as long as consent has been given for this.

# As the data subject of this data processing, you have the following rights vis-à-vis TU Wien:

- Right to information
- Right to rectification
- Right to erasure
- Right to restriction of processing of your data
- Right to data portability
- Right to object

As a data subject, you also have the right to complain to the data protection authority about allegedly unlawful data processing or non-compliance with our obligations under the GDPR.
